Thank you for your interest in **NEW NAME Ministries (NNM)** Home. Before sending out our application, we would like to share about our residential re-entry perspective.

NNM Home is a transformation home for former sex offenders, not a halfway house. Jesus doesn't do things halfway. Our ministry is driven by His healing process, rather than a program of "do's & don'ts", although we support and uphold probation, parole and treatments involvement. The men in this home are part of the process God uses for someone being renewed, restored and regenerated. **NNM**, and those in it, is committed to your success and willing to work as hard at your future as you are. If you are not intent on honoring God, yourself and others with your best, we ask that you keep looking.

The initial commitment is a **minimum** of one year. We consider accountability, integrity and responsibility invaluable and essential to becoming whole and returning to society safely. At this time, due to staffing and facility limitations, we are not able to consider any applicant with MHMR (Mental Health, Mental Retardation) diagnosis or treatment history. We are a fee-based ministry. **Applicants must have** their first month's fees of \$500, refundable security deposit of \$100 (refundable only if the one year commitment is completed) and \$50 administration fee (which is not refundable). The overall total is \$650.00. Ongoing support of \$500 per month must also be in place. Any monitoring needs must be in place before your arrival, at your expense (activated phone service with an interior jack location). You must be able to work full-time and be willing to give of your time for ministry needs when not working or looking for work.

Men are required to attend **NNM's** covering church and various faith-based and recovery meetings throughout the week as mandated by the **NNM** staff. Emotional and/or sexually entangling relationships are a danger to one's recovery during this time and forbidden while in this program. We do not accept married applicants.

We ask that you wait until you have a release date or Parole review date before sending a request. **Application Requests without two written references will not be processed.**

To see if you qualify, you must be able to honestly check yes on all the following questions posted on the back of this letter.

- I will develop and maintain a budget and goals.
- I have support for the initial \$650 and \$500/mo fees until I find work.
- I will provide two written character references with my request for an application.
